

I. THE WORLD'S FOOTWEAR INDUSTRY

1. Production and Consumption worldwide and regional

World footwear production: Worldwide footwear production in 2015 was 23 billion pairs, down microscopically (0.4%) from the previous year's performance.¹



In spite of minor variations in market share from year to year, the pattern for the footwear industry at the continental level remains fundamentally unchanged. According to the first of APPICAPS (Portuguese Footwear, Component and Leather Goods Manufacturer's Association)'s yearbooks published in 2011, Asia is the footwear industry's hub with its 87% of the world production with China performing as the undisputed leader. However, in 2015, Chinese production decreased 5%, and its market share dropped to 59%, the lowest level ever in their records. On the other hand, India, Vietnam and Indonesia were reinforcing their positions.²

Import

Europe is the leading importer of footwear, but its share of the world total continues to decrease, down to 36% (World Footwear Year Book 2016). Nevertheless, this figure is still three times higher than that of the world's population. This high level of outside purchasing is a function of European consumers' superior purchasing power and European markets' friendly openness. This is also true for North America and Oceania. On the other hand, for Africa, Asia and South America this ratio goes down six times to a paltry 50%. The only change this year to the list of the top 10 importers of footwear is Belgium's entry at number eight, pushing Russia off the listing. The USA continues to be the largest importing country as the destination of one out of every five pairs of footwear imported worldwide. European countries take six of the top ten spots in this table, with Asia garnering the remaining three.

Export

Eighty-five percent of all pairs of footwear exported worldwide in 2015 came from Asian countries, a percentage just slightly lower than that of the prior year. Of other continents, Europe is the only one to maintain more than a nominal share of the world trade (13%), mainly due to Intra-European trade. No other continent exports more than 1% of the world total. ³

World footwear consumption

Asia, making up 60% of the world's population, continues to increase its lead as the largest footwearconsuming continent, consuming 53% of global footwear production. At the country level, China is the largest footwear market, buying almost one out of every five pairs of shoes sold worldwide, accounting for 18% of the world's total output (2.5 pairs/person/year). Europe and North America still consume footwear higher than their populations would suggest. Europe consumes 16%, North America 16%, Africa 7%, South America 7% and Oceania 1%.

The European footwear market was valued at US\$43 billion in 2014, and expectations are it will grow at a CAGR of 1.5% from 2015 to 2021 to account for US\$48 billion in 2021. In volume terms, the European footwear market was valued at 2.1 billion units in 2014, CAGR growth of 1.2% from 2015 to 2021 to account for 2.3 billion units in 2021.

The North American footwear market was pegged at US\$ 81 billion in 2014 and estimated to reach US\$90 billion by 202. Expectations are that the market will grow at a CAGR of 1.5% during the forecast period.

2. International trade dynamics

The World Footwear Yearbook estimated that after five years of double-digit growth, international footwear trade would decline in 2015. Specifically, the number of pairs exported fell 5% to 14 billion, their value by 5%, to 127 billion dollars. Despite similarities between these movements, the fall in quantity was driven almost entirely by Asian countries (responsible for 97% of the variation), while the decrease in value was mainly explained by European players' performance (responsible for 2/3rds of the movement), a function of Euro depreciation. The estimate is that this footwear market would be experiencing several changes as different patterns, meaning various footwear categories would evolve. The U.K. market for footwear as compared to the other European regional markets would be, expectations document, would experience high growth during the forecast period followed by the Germany and France.

Market trends are indicating that athletic footwear is in a decline stage across Europe, with consumers progressively favoring non-athletic footwear. Why? Reasons include: (1) Rising purchasing power of young people, (2) increasing fashion consciousness towards footwear products, and (3) others are now driving the growth of the footwear market in Europe. The non-athletic footwear segment led the footwear

market in the region in 2014 and was expected to continue maintaining its highest revenue share from 2015 to 2021. The superior performance of the products and higher numbers of working women and the growing middle class also act as major drivers for non-athletic footwear growth in Europe. Moreover, the transforming fashion trends, introduction of new footwear styles (including ethical footwear and recycled footwear), and technological innovations for comfortable footwear are fuelling Europe's footwear market expansion. Finally, factors such as availability of ethnic shoes of better designs, more online sales, and soft and lightweight shoe availability should be increasing footwear demand in the region.

Sales of all types of women's and children's shoes generate the footwear revenue. European consumers mostly favor non-athletic footwear, considering changes in lifestyle and increasing numbers of workers in the region. Discussing revenue, expectation is that the footwear market will be growing at a 1.2% CAGR during the forecast period due to demand for non-athletic footwear increasing. Major drivers for this market are: (1) young people's increasing purchasing power, and (2) consumers' increasing fashion consciousness about footwear. Apart from the aforementioned factors, product innovation and demand for enhanced comfort level are stimulating footwear buys in France and Germany, turn fuelling footwear growth in Europe. Moreover, rising preference for fashionable and durable non-athletic footwear should be continually influencing growth of the footwear market in Europe's major countries; these include the UK, Germany, Italy, Spain, and France. Europe footwear market leaders include Nike, Puma, Adidas, and Crocs. In Europe, footwear distribution is mainly through hypermarkets, supermarkets, online sale, sports retailers, and department stores.

Based on gender type, the European footwear market segments into kids, women's, and men's footwear. Expectations are that the men's footwear segment will be dominating European footwear throughout 2015 to 2021. Transforming fashion and brand offerings are key factors fuelling men's footwear growth in Europe. Moreover, eco-fashion products and adoption of new technological innovations in manufacturing footwear are also driving men's footwear in Europe. The footwear market segments by types of footwear into athletic footwear and non-athletic footwear. In terms of revenue and volume, the non-athletic footwear market expects to grow at a faster pace during the forecast period. Increasing varieties of products, changing fashion trends and rising purchasing power of young people are major drivers for Europe's footwear growth. Key manufacturers include Adidas, Nike, Puma, Deichmann and Batas.

North America's footwear market expects to show various trends such as innovations and new styles in

a range of footwear categories. One can segment footwear by type into athletic footwear and non-athletic footwear. Athletic footwear further subcategorizes into shoe inserts, sports (cross training), hiking shoes and hiking boots. Non-athletic footwear further subcategorizes into dress and formal, casual footwear and fashion footwear. In terms of gender, the market segments into men footwear, women footwear and kid footwear. Growing athlete numbers, along with emphasizing staying active and fit, are some factors that will be fuelling North American footwear growth. Expect the athletic footwear segment to grow faster in comparison to the non-athletic footwear segment. The U.S. market, no surprise, is the highestvalue market in North America, with Canada and Mexico following. Factory outlets, department stores, online sellers, discount stores and other distribution channels serve as the main distributors of North American footwear.

Consumers' growing fashion consciousness is also driving footwear demand in North America. Further, innovations in product designs, health and wellness trends and active promotions by footwear manufacturers are also driving the North American footwear demand. The footwear market in the U.S. is experiencing growth due to the influx of new and innovative designs coupled with increasing consumer awareness for healthy lifestyles. Because of their multipurpose use, athletic shoes can be worn for casual wear; that is part of their scope too, thus contributing to the segment's growth. Additionally, the rampant increase of online sales is also affecting North American footwear sales, to the point of "brick and mortar" stores closing all the time now. Using online platforms is easy and available. The North American footwear markets growing a great deal too because of growth in the number of athletes in the region and because of their popularity. Increasing numbers of women in the North American workforce is leading to the women's footwear growth. These factors are combining to influence the North American footwear market positively.

In North America, the U.S., of course, reaps the largest market share and revenue, and that will continue. Canada follows the U.S. in revenue; that will be remaining the same.

The region operates with numerous brands; large numbers of them are into multi-segments while others' strategy is performing in a limited segmental scope. Here are some of the major manufacturers: Adidas, Nike, Sketchers, New Balance, and Aldo

A VIETNAM FOOTWEAR INDUSTRY OVERVIEW

Vietnam's leather and footwear industry is an important producer of fashion goods for export and domestic consumption.

1. Period of 2011-2016

Vietnam's export value for leather and footwear grew in a stable manner every year during the 2011-16 period to reach US\$57.5 billion in total. This period was fast growing for Vietnam's leather and footwear industry. During it, this industry's exports increased from US\$7 billion in 2011 to US\$13billion in 2016, up 14%/year. Traditional markets - such as the US, EU and Japan - grew remarkably. According to McKinsey's apparel CPO survey 2013 on "the worldwide future leather and footwear sourcing", Vietnam was number two as a continuous-sourcing country for international buyers. Bangladesh was the number one.

The General Department of Customs' data documented that export value in 2011 wasUS\$6.5 billion, in 2012 it was US\$7.3 billion, in 2013 it was US\$8.4 billion, it wasUS\$10.3 billion in 2014, it was US\$12 billion in 2015, and US\$13 billion in 2016

The statistics set forth that during these years, the footwear export cycle usually was growing in the second guarter, reaching the highest level in the third guarter. In 2016, the products' average export value was \$1.1 billion/month. The US is the largest buyer of Vietnam's footwear, accounting for 30% of the industry's total export value. Footwear export value made up 11% of Vietnam's total export value to the US.

In 2016, the US, the largest footwear export market for Vietnam, was responsible for revenue of \$4.5 billion, up 10% against that of the previous year. China's export value of \$905millionplaced it second, followed by Belgium \$825 million, Germany with \$765 million, and Japan at \$675 million. In regional terms, the EU was the largest footwear importer of Vietnam's footwear. Footwear exports from Vietnam to the EU will be increasing further with the signing of the EU-Vietnam Free Trade Agreement.

Vietnam's footwear industry, with its long developmental history, is an industry with export advantages, and it contributes significantly to economy. The Vietnamese Leather Footwear and Handbags Association (LEFASO)'s data show that the industry's export for 2009-2016 was rising even in the crisis that led to difficult domestic and international economic times. Despite a decline in 2012, exports to EU continued to increase during 2013-2016. The U.S., EU, China and Japan are now remaining as Vietnam's leather and footwear industry's largest buyers.

Footwear industry analysts find that the recent productions tend to be located either at the beginning of the value chain (preproduction activities such as R&D, design, core inputs) or at its end (postproduction activities such as marketing, advertising, logistics and sales). These tasks tend to be more relationshipspecific and knowledge intensive, therefore generally conducted in high-income countries such as Italy, UK, and Germany.⁴ These countries have comparative advantage in knowledge and contract-intensive tasks, and they naturally specialize in upstream activities. We call those countries' companies lead firms, normally large retailers and brand owners, which in most cases outsource the manufacturing process to a global network of suppliers. Those lead firms have an abundant effect on the remaining companies that participate in the global value chain (GVC). The lower value-added tasks, in contrast, tend to concentrated on downstream assembly activities. These tasks are more standardized, labour-intensive, and commonly situated in medium- and low-income countries such as Brazil, China, Vietnam, and India.

In the global footwear value chain, developing countries normally provide much of the semi-finished inputs used by developed countries' exporters such as raw leather. At the same time, these countries

import leather (as core inputs), design, R&D, and especially, brand names. However, in Vietnam's case, raw material capability is unsatisfied both qualitatively and quantitatively. According to international export standards, Vietnamese footwear manufacturers must import raw leather, tanned leather and other producing inputs. Except for labor advantages, Vietnam's footwear industry is obviously unable to provide anything to participating in GVCs. Employment creation - the obvious comparative advantage of Vietnam's footwear exports - may be the major benefit that Vietnam has enjoyed from participating in GVCs.

Sector Perspective

In the global supply chains of giant manufacturers such as Nike and Adidas, Vietnamese companies are at a passive position with their operating only as outsourced companies, and their production heavily relies on the outsourcers' orders. Vietnam faces paradox whereby it is a powerhouse for leather and footwear products, but domestic enterprises are overwhelmed both at home and abroad. There are 800 enterprises operating in this sector in Vietnam, of which the foreign-invested enterprises account for only 23% but contribute 65% of export revenues. The domestic market, consuming 180 million pairs of shoes worth US\$5 billion/year, is also dominated by foreign enterprises with Chinese ones controlling the segment of cheap products and other foreign brands ruling the high-end segment. Such a challenging situation requires Vietnamese enterprises to be more proactive to deal with the shortage of funds, technology and senior staff, as well as low management capacity and poor labor productivity. They also should pay more attention to research and market analysis, standardize quality, increase staff training, form supply chains between domestic enterprises, meet rules of origins and the requirements of environmental protection, labor and technological processes.

III. PRODUCTION CAPACITY OF VIETNAM'S LEATHER AND FOOTWEAR INDUSTRY 1. Industry's scale

According to Vietnam's General Statistics Office (GSO), 1,696 enterprises have registered to operate the country's leather and footwear industry in 2015. Growth of the leather and footwear enterprises has averaged an enviable 9%/year during the period of 2010 to 2015, accounting for 2.6% of the total enterprises in the manufacturing and processing industries.

The number of companies in Vietnam's leather and footwear industry is less than the number of companies in textiles and garments, construction, wholesale and retail industries, but bigger than other industries. Within the industry, the number of footwear enterprises was the biggest, accounting for 55%, followed by companies doing business in travel bags (42%) and leather tanneries (3%). The Leather and footwear industry employs a massive number (1.14 million) of Vietnamese. That is 18% of the total labor pool of the manufacturing and processing industries.


The leather and footwear enterprises are mostly small and medium (SME) sized companies:

Quantifying the labor pool, 58% of the industry's enterprises operate with less than 50 employees, 22% have 50-300 employees, 5% have 300-500 employees, and 15% have more than 500 employees.

In capital terms, up to 81% of the enterprises are at less than VND50 billion (US\$2.2 million) capitalization, and only 19% of the enterprises exceed VND50 billion capitalization



Figure 2: Percentage of labours in Vietnam Footwear Manufacturers




It is very hard for SMEs to: (i) garner large export orders, (ii) be able change to new and modern machinery and technology, or (iii) limit employee turnover. These constraints reduce Vietnamese enterprises' competiveness against foreign direct investment (FDI) ones. The FDI are small in number, but large in capital and employment - most FDI companies employ 5,000 or more, with some massive companies even employing more than 10,000.

2. Production capacity of Vietnam

The global economic crisis in 2008 subsequently slowed down the export volume of Vietnam's leather and footwear industry. Spin-off effects were: (i) paying more attention to the domestic market, (ii) expanding distribution channels for anticipated domestic consumption improvement, and(iii) at the same time improving the service of existing footwear distribution channels and enhanced domestic market with high-quality and affordable prices for Vietnamese footwear products. These policies result in the industry's maintaining its continuous production for export and domestic markets, creating sustainable employment, and other advantages.

Quantifying the categories of manufacturers, those in footwear are of the majority - 70%. Enterprises in other sectors such as tanneries and materials and accessories make up the other 30%. The number of enterprises, regardless company size, is the basis of these two percentages. Most of the tanneries and materials & accessories input suppliers in Vietnam are SMEs of small-size production, unable to meet demands of processing partners when it comes to varieties, quality, as well as scope of product supply.

What is the associated negative effect? (i) Vietnamese footwear processing enterprises must import most raw materials and accessories for production of export products and in large quantity and of high quality. (ii) Domestic production of materials and accessories for the footwear industry must be for lower quality footwear, mainly for domestic consumption or exporting to less developed countries.

The localization ratio of the leather and footwear sector is at a mere 40%, mainly from relatively unimportant items such as shoe soles, thread and fabrics for low-grade canvas shoe production. Meanwhile, those in the sector must import most machines and important materials for production such as high-end fabrics and artificial leather. Tanned leather imports were at US\$1.56 billion in 2016. In global footwear supply chains of world-leading brands such as Nike and Adidas, Vietnamese companies are operating as their offshore outsourcers with production orders assigned by foreign importers. Paradoxically, Vietnam is a major footwear producer and exporter, but its domestic firms are sufferers of squeezing in both domestic and international markets. Vietnam has 800 footwear companies, of which FDI companies account for 23% but contribute 80% of the export revenue.

Domestic market demand is 180 million pairs of footwear worth US\$ 5 billion/year, with foreign businesses garnering 60% of it. (China dominates the cheap segment while foreign brands control the upmarket segment). Indeed, Vietnamese companies are dealing with capital shortage, technology, senior human resources, governance, and low labor productivity. What is the corrective action? Attach much importance to market research and analysis, quality standardization, personnel training, production and supply chain formation to meet origin rules, requirements on quality, hygiene, labour and technology.

Developmental targets - as set forth in the General development plan of Vietnam's leather and footwear industry to 2020 and vision to 2030 - are taking initiatives in the direction of increasing production of materials and accessories in Vietnam. However, the investments in materials' and accessories' production need large financial allocation. Related to this is the world nowadays being an open global market whereby we can procure any kind of material inputs with acceptable price and suitable quality.

The increase of prices or limited sources of supply for input materials are the same "concern" for footwear producers worldwide, not only in Vietnam. Instead of using precious and limited land to build more leather tanneries (highly polluting), better to table this investment in favor of alternative footwear and handbag productions of high technology, green production, and high productivity.


Further, it is important for the industry to look for a new production model instead of the present pure processing production and to create brands for Vietnamese footwear and raise the images of Vietnam's leather and footwear industry for a better place in Asia, in particular, and globally in general.



IV. Fast growth in Vietnam's leather and footwear exports

Vietnam's footwear exports have been significantly improving, especially after joining the WTO that reduced custom tariffs in importer countries. Thanks would also have to go to the Vietnamese Government's policies of encouraging foreign investments and opening of export markets worldwide. Continuous trade promotion enhancement, particularly that under national trade promotion programs, are helping Vietnamese enterprises find partners and expand export markets, as well as attract foreign investors for building new facilities for footwear production in Vietnam. The industry diversifies footwear products to meet various demands from importers and widen the scope of supply and increase footwear production, improving the export structure for footwear products as follows:

1. Two-digit export growth during 2010-2016

GSO figures document that for 2010-2016, average export of leather and footwear products increased 18%/year for footwear; 24%/year for handbags, travel goods, and wallets; and 22%/year for materials and accessories.

Eighty percent of Vietnam's leather and footwear enterprises operating in Vietnam are on a processing contract basis for export, of which most of the foreign invested enterprises (FDI) have global supply chains of materials, and produce finished products for international footwear brands. This is the main reason why Vietnam's leather and footwear export revenue sharply increased during this 2010-2016 period.

In 2016, the United States was the largest single buyer of Vietnam's footwear export. It bought 36% of Vietnam's footwear exports. The value of the United States' buys were US\$4.7 billion, up 10% compared to that of 2015.

Vietnam's footwear export to the EU was US\$4.16 billion, an increase of 20% and amounting to 33% of Vietnam's footwear exports. China's buys followed at US\$754.2 million (accounting for 6.3%, up 49%). Japan imported US\$598 million (5% of Vietnam's subject exports, up 15%).

Looking at value, most of Vietnam's footwear export markets in 2016 were associated with higher export values than in 2015. Footwear export to China remarkably increased due to growing Chinese labor costs. Moreover, the collapse of the Chinese Yuan is creating pressure on footwear processors in China. As a result, many investors in China are moving their footwear production - particularly sport shoes, canvas and leather shoes - to Vietnam for further export.

Noticeably, FDI enterprises continue to be major elements of Vietnam's leather and footwear export, which gained US\$9.6 billion and increased by 20% over the previous year's performance, reaping 80% of Vietnamese footwear export.

A TPP without the US will be casting a shadow over the potential tax cuts and, to a certain degree, affect Vietnam's chance of boosting exports of leather and footwear products to the US, which is currently one of Vietnam's largest buyers.

However, such concerns seem unfounded, because incentives for the sector are bound to increase even if no TPP materialization.

Firstly, Vietnam's leather and footwear industry is competitive thanks to the country's economic, political and social stability in addition to its abundant supply of cheap and highly skilled labor. Vietnam is Asia's third largest footwear manufacturer and fourth in the world, accounting for 10% of the global market. Leather and footwear products are also a key export of Vietnam, contributing 10% of total export revenues. In 2016 Vietnam's revenues emanating from footwear and handbag exports reached US\$16.2 billion, up 9% from the prior year, and expect the figure to be US\$18 billion in 2017 and US\$54 billion by 2030. The export structure is seeing improvement because of high-value products performing 10% higher, double the previous 5%.

Secondly, Vietnam is establishing a firm position among exporters to the US. Despite an imposed average tax rate of 14.3% since 2011, Vietnam's footwear exports to the US are increasing 20-21% per year and the country now accounts for 10% of the US market.

Since January 1, 2014, thanks to EU's GSP, Vietnam's footwear export to EU increased by 20.5%/year. With the EVFTA taking effect, the objective hope is that by 2018, Vietnam will no longer be beneficiary of GSP preferences of the EU. The EVFTA is valuable, because most of footwear tariff lines will reduce to 0%, thus, of course, benefiting Vietnam's footwear export to EU, and the associated benefit should be growth of 20-30%/year.




Figure 5: Vietnam export quantities (pairs of shoes) to markets from 2010 - 2016

2. Materials and accessories supply

A LEFASO survey set forth that by the end of 2015 the supporting industry for leather and footwear production in Vietnam would be 129 enterprises, including tanneries and factories producing various materials and accessories for leather and footwear industry, of which:

a. Production of materials and accessories: Consists of 95 enterprises:

- **By company status:** Foreign invested enterprises (30%), Vietnamese enterprises (70%). Most of the foreign enterprises come from Taiwan, South Korea and China.

- **By location:** Ho Chi Minh city (47 enterprises), Binh Duong (27 enterprises), Dong Nai (17 enterprises), and Hanoi (5 enterprises); Hai Phong, Hung Yen, and Bac Ninh (less than 5).

- **By products:** Soles (23 enterprises); glue (11); woven fabric (4); molds (5); leatherette (6); accessories (11); paper and cardboard for packaging (4); machinery (1 enterprise); and other businesses for import and export of materials, accessories, machines and equipment for the leather and footwear industry.

b. Leather tanneries: Consists of 35 enterprises:

- By company status: private (21 enterprises), state-owned (2 enterprises), joint-stock (1 enterprise), and FDI (11 enterprises).

- By location: Ho Chi Minh city (18 enterprises), Binh Duong (1), Dong Nai (5), Hanoi (1), Can Tho (1), Khanh Hoa (1), Thai Binh (1), Lang Son (1), Hai Phong (1), and Vung Tau (1).

- Other productions: Apart from above, the supporting industry of the textile and garment industry (producing fabric, labels, zippers, buttons, elastic bands, etc.) and other enterprises producing chemicals, plastic, metal and mechanical components and also providing several kinds of materials and accessories for the leather and footwear industry.

Based on calculations of LEFASO's experts, materials and accessories take a large proportion (68-75%) of the footwear price structure. However, the ratio of domestic production of materials accounts for only 40-45%, with most of the important materials - such as tanning leather, artificial leather (leatherette), and fabrics for shoe uppers - having to be imported.

According to Vietnam's General Statistics Office (GSO), the average growth rate of the index of industrial production (IIP) of the leather and footwear supporting industry was 16%/year for the period of 2006-2011. In 2011, the IIP index of supporting industry for leather and footwear was 20% of the country's production of supporting industries (including for textiles, electronics, mechanics, etc.). Tables 7 and 8 below quantify leather, machinery and equipment imports during 2010-2015.



c. Major import markets for material & accessories:

- Leather: Korea (18%), Taiwan (14%), Thailand (11%), China (9%), and others
- Materials and accessories: China (60%), Taiwan (20%), Korea (10%), and others (10%)
- Machinery: Taiwan (49%), China (35%), Korea (9%), and others (6%)

3. Opportunity and challenges of footwear – handbags and material

Having 20 years of establishing and developing, Vietnam's leather and footwear sector has made significant progress and been considered one of key industries promoting the development of Vietnam's economy. In the context of international economic integration, Vietnam's leather footwear sector not only offers opportunities to develop but also for solving challenges.

According to Vietnam's esteemed Ministry of Industry and Trade, Vietnam's leather and footwear products are exported to its main markets of the EU, North America, Asian countries, and South America, etc., accounting for 10% of the world's market share. Leather footwear is in the top three products with the highest export revenue of Vietnam, ranking only after crude oil and garments. A thousand enterprises are operating in the leather and footwear sector, employing 720,000 Vietnamese. The sector additionally involves thousands of private businesses and craft villages producing footwear with tens of thousands of employees, satisfying domestic demand and manufacturing for export.

Many opportunities and reasons now exist for becoming part of the leather footwear sector. Specifically: (i) A young and skilled labor force - who will satisfy employee needs to serve further development of the sector – is in place. (ii) The domestic market, with 90 million consumers, is also an opportunity for local enterprises. (iii) The ASEAN Economic Community has been in place to help market expansion and generate more opportunities for Vietnam's leather footwear sector.

Along with opportunity, the leather footwear sector will be facing multiple challenges. The Vietnamese leather and footwear enterprises still have an adequate number of weaknesses and difficulties.

Firstly, they only can perform in some certain activities of the total value chain of global footwear products; therefore, only very few enterprises are initiating manufacturing for producing materials and accessories for leather and footwear.

Secondly, enterprises cannot take initiative in sourcing materials; instead, they have to depend on customers and suppliers from China, South Korea and Taiwan instead. Apart from that, they also lack staple materials - such as leather, PVC plastic, PU paint, fabrics, accessories material, skilled technicians,

technological engineers, product development and marketing capacity. As a result, enterprises will need to improve their production and export capacity to compete and enhance competitiveness of their products for the market.

The sector will be encountering production difficulties, because many companies perform offshore contracting for foreign partners. Many accomplish the low-value stages in the global supply chain. In addition, they will see difficulties in non-tariff barriers, because their competitiveness, technical competence and designing capacity are weak while importers are always strict in demanding quality, delivery, and technical specifications. To penetrate developed markets such as the US and Japan, they cannot limit themselves with mere average products, but must achieve higher-grade product lines.

The 21st century consumer is more educated and knowledgeable; hence, are now more demanding. The number of consumers who search for information and favor supporting certain causes is rapidly increasing. Does this present a serious challenge for shoemakers? Yes. Vietnam footwear enterprises can be responsive by following and quickly adapting to consumer preferences. The consumers' preference is, of course, fundamental in her and his personal purchasing decisions.



V. POLICIES FOR EXPORT PROMOTION 1. Government Policy

Through Decision No. 6209/QD-BCT dated November 25, 2010, the Minister of Industry and Trade approved the master plan for the development of Vietnam's leather and footwear industry up to 2020 with a vision to 2025. The overall objectives of the development up to 2020 are: (i) To build Vietnam's leather and footwear industry into an important industry for exporting and benefiting the national economy. (ii) To continue to hold the position in

the group of countries producing and exporting superior leather and footwear products for worldwide consumption. (iii) To create more jobs for society, increase incomes of employees, and increase social responsibility.

According to "Development planning for the footwear industry in Vietnam by 2025, vision 2035", export revenue of the entire sector in 2020 should be US\$24-26 billion, by 2025 it should improve to US\$35-38 billion, and in 2035 attain US\$50–60 billion.

Competitiveness for the sector and the building and development of training facilities, scientific and technological research facilities, accreditation centers, industry services and trade promotion centers, home and abroad, are long-term foci to develop the industry towards stability and sustainability. In particular, some targets, including targets set forth in the master plan, are doing marvellously in implementation - such as footwear industry planning in an open direction with the basic completion of the capitalizing of state-owned enterprises, joint ventures, and associations of all economic sectors to improve conditions conductive for businesses in the industry to thrive.

For the footwear sector of Vietnam, basic footwear is still to be the key component of the sector through 2020. However, production of fashion leather footwear and high-quality purses will be more of a focus. For leather products, the industry will focus on leather production with advanced and environmentally friendly technology. Investment in leather production is symbiotic with livestock development, and will reduce trade deficits and generate production proactivity.

2. International Trade Agreement

Vietnam - EU Free Trade Agreement (EVFTA): In June 2012, Vietnam and the EU formally launched negotiations for a comprehensive free trade agreement. The parties undertook their eighth round of negotiations in June 2014, with both parties aiming towards a swift conclusion of the negotiations. The FTA agreement will be covering, at a minimum, 9 areas: (i) market access for trade in goods: elimination of tariff and non-tariff measures, addressing SPS and TBT issues, trade facilitation, customs cooperation, and rules of origin; (ii) commitments for liberalization of trade in services; (iii) investment; (iv) competition; (v) intellectual property rights, including geographical indications; (vi) government procurement; (vi) regulatory environment; (viii) sustainable development, including labor issues; and (ix) state-owned enterprises.⁶

Accordingly, Vietnam's footwear industry faces fabulous opportunities to strengthen and expand market share in EU when EVFTA goes into effect. EVFTA translates to the majority of tariff lines decreasing to 0% (within 7 years), creating favorable momentum for footwear exports to the EU, with growth going to between 20 and 30%.

Along with the presence of foreign investors, the footwear industry is making great strides. The sector is satisfying the requirement of rules of origin when the localization rate is up to 55%. A number of manufacturing enterprises are meeting export requirements and are improving on delivery progress, taking the initiative in organizing production and strengthening links with, for example, suppliers of material.

The Vietnam - Japan Economic Partnership Agreement (VJEPA: VJEPA is the first bilateral free trade agreement that Vietnam entered into after the country joined the World Trade Organization in January 2007. When VJEPA went into effect October 2009, Vietnam committed to eliminating 91% of tariff lines for Japan within 16 years, while Japan pledged to eliminate 94% of tariff lines for Vietnam within 10 years.

Vietnam - Eurasian Economic Union FTA: Signing of the Vietnam-EAEU FTA was in Burabay, Kazakhstan on May 29, 2015 to take effect on October 5, 2016. Under the agreement, Vietnam will remove import tariffs on 59% of the total tax lines on goods from the EAEU, including meat products, wheat flour, alcohol, mechanical equipment and steel. There will be the gradual tariff reducing to 0% for 30% of the goods in the transitional period. The average level of Vietnam's duties on EAEU goods will drop from 10% to 1%,

while EAEU's average import tariffs on Vietnam's goods are going from 9.7% to 2% in 2025. The tax removal will spur the EAEU's export of agricultural and industrial products to Vietnam and vice versa. As a result, Vietnam's farm produce, garments, bags and electrical devices will have better access to the EAEU market.

Two-way trade reached US\$2.8 billion in the first eight months of 2017, a year-on-year rise of 24%. Vietnam exported goods to the Union worth US\$2.0 billion, up 30%, while the EAEU exports to the Southeast Asian nations were US\$825 million, up 11%, according to the EAEU statistics.

Figures from Customs of Vietnam illustrate that trade between Vietnam and Russia wasUS\$2.3 billion in January-August, up 29% against the same period of the prior year, in which Vietnam's exports were valued at US\$1.4 billion, up 37%, and Russia's shipments were US\$859 million, up 18%. Vietnam's main export products include seafood, vegetables and fruits, garments-textiles, footwear, electronics and spare parts. However, Vietnam's exports to Russia continue to meet some difficulties. They include insufficient value-added products, payment, and geographical distance, thereby reducing competitiveness of madein-Vietnam goods compared to competitors such as India, China and Thailand.

Free Trade Agreement between Vietnam and Korea (VKFTA): Signing was May 5, 2015, officially going into effect on December 20, 2015. Compared to FTA ASEAN – Korea (AKFTA), VKFTA contains more preferences that the Parties gave to each other in the field of goods, services and investment. However, VKFTA does not replace AKFTA. These two FTAs coexist, and enterprises can choose to use the more favorable one. By 2020, total footwear of all kinds should reach 1.6 billion pairs; suitcases, bags, and similar items were at the level of 300 million pieces; leather at 63 thousand tons; and soft leather 277 million items. (Vietnam News).

3. Export forecast

According to the General Statistics Office, export activities of enterprises in the industry in the first half of this year were positive compared to the same period in 2016 with total export revenueat US\$8.8 billion, up 11% (footwear exports were estimated at US\$7.1 billion, up 12%), and export bags wereUS\$1.7 billion, up 4%. For 2017, international experts forecast that the world economy will be more prosperous than 2016, and China continues to advocate cutting investment incentives in the areas of textiles and footwear to focus on higher technology industries. It is likely that some orders for processing footwear and handbags will move from China to Vietnam, taking advantage of the prospect that the EVFTA agreement will go into force in 2018.

Based on world market trends and Vietnam's trends discussed immediately above, Vietnam Customs News notes that production and export of leather and footwear in 2017 will have higher growth than in 2016. Specifically, the Industrial Production Index indicates that footwear should be reaching 5%, footwear exports up 10%, hand bags up 12% over 2016, and total export revenue of the whole industry at US\$18 billion, up 10% compared with 2016.


